# Power of Attorney Forms

## Fòmilè Pwokirasyon

### What do these forms do?

These documents let you name a person who will care for your children if you become detained or deported. Indiana law calls this person an attorney-in-fact. Most people also call them their “POA.”

These forms let you say who has the right to act as your child’s parent until your child is 18 years old or you can take care of your child again. The POA has the responsibility to make decisions for your child like getting medical care, schooling. The POA has the responsibility to care for your child day to day by giving them a safe place to live, feeding, and clothing them.

These forms do not create a legal guardianship for your child . That is called a minor guardianship and is something only a court can do. Information about that is at <https://indianalegalhelp.org/legal-topic-category/minor-child-guardianship/>

### Do you need these forms?

You may need these forms if you want to control who will take care of your child if you cannot take care of them.

If both of your child’s parents could be detained or deported, then each parent should sign a Power of Attorney document. It is best if both parents say the same person will be their attorney in fact.

You don’t need these forms if your child’s other parent is a US Citizen or is not at risk of deportation or detention and has custody or parenting time (also called visitation) with your child. This is because the law says your child’s other parent will have custody of your child, unless there is a court order saying different.

You may also need these forms if there is no other parent listed on the child’s birth certificate, no person has signed a paternity affidavit, or if a court has not said who the other parent is. A court would say that in a custody order, a divorce decree, a visitation order, or an adoption decree.

### Who should I name as my attorney-in-fact/POA?

The person you choose should be someone you know and trust to provide proper care for your child. Make sure you talk to the person you want to choose to see if that person is willing and able to care for your child.

### If I sign these forms, will I lose custody of my children?

NO. The documents only allow the other person to care for your children if you become detained or deported. You can cancel or revoke these documents later.

### Èske w bezwen fòmilè sa yo?

Ou ka bezwen fòmilè sa yo si ou vle kontwole ki moun ki pral pran swen ptit ou a si ou pa kapab pran swen l.

Si toude paran ptit ou a sou risk pou yo arete oswa depòte yo, nan ka sa chak paran ta dwe siyen yon dokiman Pwokirasyon. Li pi bon si toude paran yo deklare ke se menm moun nan k ap mandatè yo.

Ou pa bezwen fòmilè sa yo si lòt paran ptit ou a se yon Sitwayen Ameriken oswa si li pa gen risk pou yo depòte l oswa arete l epi si se li ki responsab ptit ou a oswa si li gen dwa vizit (yo rele li vizit tou) ptit ou a. Sa a se paske lalwa deklare ke se lòt paran ptit ou a k ap gen responsablitè ptit ou a, sof si gen yon òdonans tribinal ki di yon lòt bagay.

Moun ou chwazi a ta dwe yon moun ou konnen epi ou fè konfyans pou bay ptit ou bonjan swen. Asire w ke w pale ak moun ou vle chwazi a pou w wè si moun sa a vle ak si li kapab pran swen ptit ou a.

### Si m siyen fòmilè sa yo, èske sa vle di ptit mwen yo p ap sou responsablitè m ankò?

NON. Dokiman yo pèmèt lòt moun nan pran swen ptit ou yo sèlman si yo mete w nan prizon oswa depòte w. Ou ka anile oswa revoke dokiman sa yo alavni.

### How to Fill out this form

#### 1. Review the forms.

Read and understand the document before you sign it. If you have questions about the form or other options for your children, don't sign the forms and talk to a qualified attorney.

Applications for legal help can be made by Calling 1- 844-243-8570, Monday through Thursday 10 am to 2 pm EST, or Online anytime Monday through Friday at <https://www.indianalegalservices.org/applyonline>.

#### 2. Fill out the form everywhere you see this

Use people's full legal names. The name on the form should match the person's birth certificate, driver's license, or other government ID. Do not use nicknames on the forms.

An alternate (successor) attorney in fact is a person who will act if your first-choice attorney in fact is unable or unwilling. You do need to pick a successor attorney in fact if you have someone who agrees to act as a backup attorney in fact.

#### 3. Do not Sign the Forms Until You Are In Front of a Notary Public!

The form must be signed in front of a notary public. A notary public is not the same as a "notario." In the United States, a notary public certifies official documents and is usually not a lawyer. Notaries public who are not a lawyer cannot give legal advice. Do not rely on legal advice from a notary public that is not a lawyer.

You can find a notary at most banks. Some notaries will charge a fee to notarize, but it can't be more than \$10 per signature. For these documents, you should not be charged more than \$10.00. You will need to take a photo ID with you when you go to have the form notarized.

I, as principal and as the parent of the minor child or children named below, designate the person named above to be my attorney in fact. Under Indiana Code § 29-3-9-1, I delegate to the attorney in fact any and all parental powers regarding the health care, support, custody, education, and property for the child or children named below except the power to consent to the marriage or adoption of the child or children named below. The child or children named below shall be collectively referred to in this Power of Attorney as the "Child(ren)".

The express purpose of this Power of Attorney is to allow the attorney in fact to do all things necessary for the Child(ren)'s care. This delegation of parental power includes but is not limited to the following powers:

*Objektif espesifik Pwokirasyon sa a bay mandatè a otorizasyon pou li fè tout sa ki nesesè pou swen Timoun nan (yo). Delegasyon pouvwa parantal sa a gen ladan, men se pa sa sèlman, pouvwa sa yo:*

1. All medical, dental, and other health care-related matters, including but not limited to consenting to medical treatment and authorization to receive all medical records and information. The attorney in fact shall have general authority with respect to all health care matters for the Child(ren) as described in Indiana Code § 30-5-5-16, and I appoint the attorney in fact to serve as the health care representative for the Child(ren) pursuant to Indiana § Code 16-36-1, et seq.

2. All education and school-related matters, including but not limited to enrolling the Child(ren) in school and school-related programs, attending school functions and meetings, authorization to sign consent and waiver forms, and authorization to receive all school-related documents and information.

3. All matters related to Medicaid, Hoosier Healthwise, or any other health insurance, Supplemental Nutrition Assistance Program (SNAP) benefits, Social Security and Supplemental Security Income (SSI) benefits, and all other benefits for the Child(ren). The attorney in fact shall be appointed as the authorized representative for any such benefits for the Child(ren).

4. Travel with the Child(ren), including travel outside of the United States of America. The attorney in fact has permission and authority to apply for a passport, visa, and any other travel document for the Child(ren).

5. Any and all other actions that may be necessary for the care and benefit of the Child(ren), except the power to consent to the marriage or adoption of the Child(ren).

This Power of Attorney shall become effective immediately upon: 1) my detention by U.S. immigration authorities or by any other federal, state or local law enforcement authorities, or 2) my deportation (removal) from the United States of America. A statement by the attorney in fact that any of the preceding events have occurred shall be sufficient to verify that this Power of Attorney is in effect. This Power of Attorney shall be effective for a period of twelve (12) months after its effective date.

I am not waiving or surrendering any parental rights or authority that I have regarding the Child(ren) by executing this Power of Attorney. I reserve unto myself the power to act on my own behalf regarding the Child(ren). I may revoke or amend this Power of Attorney at any time by signing a written document that revokes or amends this Power of Attorney.

The attorney in fact shall communicate with me regarding the Child(ren), and shall ensure that the Child(ren) communicate with me, at all times to the extent reasonably possible. The attorney in fact shall provide me with the current address and other contact information of the Child(ren) and the attorney in fact at all times.

## What to do after you sign the power of attorney form

After the form is notarized, it is official! You don't need to give a copy to a court or the government, but you should:

1. Give a copy of the form to the attorney in fact.
2. Keep the original copy of the form in a safe place. It is a good idea to save a clear picture of the form in your email, phone, or cloud storage.

Even though this form is official, you or the attorney in fact may need other forms later. If your child goes to public school, the attorney in fact will need an Indiana Department of Education Form 2 to enroll the child in school. That form is at <https://www.in.gov/doe/home/other-legal-forms>. There are separate forms to get a passport and to travel outside of the United States

### How long does this form last?

The form lasts for 12 months from when you are detained or deported. This means you may need to sign new forms if you are detained and then released. If you sign new forms, destroy all old documents.

### Can I change my mind?

YES. You may revoke (or end) this document at any time in writing. This is called a revocation. To revoke the POA:

1. Write "I now revoke the Power of Attorney Delegating Parental Powers for Minor Child that I granted to [insert name of attorney in fact] and that I signed on [insert the date that you previously signed the Power of Attorney document], effective immediately."
2. Sign and print your name and write the date on which you are signing the revocation.
3. Give a copy of this written revocation to the attorney in fact. The Power of Attorney will not be revoked until you tell the attorney in fact that it has been revoked.
4. Give a copy of the written revocation to your child(ren)'s school and doctors if they were given a copy of the power of attorney by you or the attorney in fact.



# Other Safety Planning Lòt Plan Sekirite



If you are undocumented or at risk of detention or deportation, here are some things you can do to protect yourself and your family.

## What else can I do for my children?

- ✓ Make a list of people to call in case of an emergency, including attorneys and consulates.
- ✓ Give the attorney in fact your child(ren)'s medical information like the food and medicine your child is allergic to, the medicines your child takes, the name of your child's doctors, and when your child's next checkups are due.
- ✓ Give the attorney in fact your child(ren)'s school information like how to contact the school, who their teachers are, and routines for your children.
- ✓ Let the attorney in fact know things that will help your child(ren) adjust like their favorite foods, toy, and hobbies.
- ✓ Make sure schools have updated emergency contact information.
- ✓ Get US-born children Passports and register their birth with your consulate.
- ✓ Have a list of your and your family's non-citizen numbers. This is a nine-digit number beginning with an "A". You can use this number to locate people who have been detailed [at https://locator.ice.gov/odls/#/search](https://locator.ice.gov/odls/#/search)

**Collect and organize documents you will need if you are detained or deported and keep an electronic copy on your phone, email or cloud storage.**

- ✓ Identification like passports, photo IDs and birth certificates
- ✓ Immigration Records, including applications or notices from immigration authorities
- ✓ Medical Records, including prescription information, treatment and medical conditions
- ✓ Financial Records like Bank statements, pay stubs and tax filings. Set up online banking
- ✓ Legal Records such as Marriage certificates, divorce orders, custody agreements



## Other Safety Planning Lòt Plan Sekirite



### Carry proof of your immigration status or pending application

This can be a LPR/"green card" or approval notice or work authorization.

**Do not carry a foreign passport if you do not have lawful immigration status in the US.**

#### Beware of notaries

In the United States, a notary public certifies official documents but usually are not a lawyer. Do not rely on legal advice from a notary public that is not an attorney. You see if someone is a licensed Indiana Attorney at <https://courtapps.in.gov/rollofattorneys>

#### Attend all immigration court hearings

Those who have hearings set in immigration court must attend. But only people who are in proceedings should go. Do not bring people to court who do not have lawful immigration status. You can check the status of immigration court hearings at <https://acis.eoir.justice.gov/en/>

## Know Your Rights Under the U.S. Constitution - No Matter Who is President

Last updated April 2024

---

No matter who is president, *everyone living in the U.S. has certain basic rights* under the U.S. Constitution. Undocumented immigrants have these rights, too. It is important that we all assert and protect our basic rights.

If you find you have to deal with Immigration and Customs Enforcement (ICE) or other law enforcement officers at home, on the street, or anywhere else, remember that you have the rights described in this factsheet. The factsheet also provides suggestions for what you should do to assert your rights.

- ▶ **You have the right to remain silent. You may refuse to speak to immigration officers.**
  - ▶ Don't answer any questions. You may also say that you want to remain silent.
  - ▶ Don't say anything about where you were born or how you entered the U.S.
- ▶ **Carry a know-your-rights card and show it if an immigration officer stops you.**
  - ▶ The card explains that you will remain silent and that you wish to speak with an attorney. You can use the card attached below.
- ▶ **Do not open your door.**
  - ▶ To be allowed to enter your home, ICE must have a warrant signed by a judge. Do not open your door unless an ICE agent shows you a warrant. (They almost never have one). If an ICE agent wants to show you a warrant, they can hold it against a window or slide it under the door. To be valid, the warrant must have your correct name and address on it.

- ▶ You do not need to open the door to talk with an ICE agent. Once you open the door, it is much harder to refuse to answer questions.
- ▶ **You have the right to speak to a lawyer.**
  - ▶ You can simply say, “I need to speak to my attorney.”
  - ▶ You may have your lawyer with you if ICE or other law enforcement questions you.
- ▶ **Before you sign anything, talk to a lawyer.**
  - ▶ ICE may try to get you to sign away your right to see a lawyer or a judge. Be sure you understand what a document actually says *before* signing it.
- ▶ **Always carry with you any valid immigration document you have.**
  - ▶ For example, if you have a valid work permit or green card, be sure to have it with you in case you need to show it for identification purposes.
  - ▶ Do not carry papers from another country with you, such as a foreign passport. Such papers could be used against you in the deportation process.
- ▶ **If you are worried ICE will arrest you, let the officer know if you have children.**
  - ▶ If you are the parent or primary caregiver of a U.S. citizen or permanent resident who is under age 18, ICE *may* “exercise discretion” and let you go.

**ICE and other law enforcement officers may think they can get away with violating your rights.** Sometimes ICE officers lie to people to get them to open their doors or sign away their rights. If ICE detains you or you are concerned that they will conduct raids in your area, this is what you can do:

- ▶ **Create a safety plan.**
  - ▶ Memorize the phone number of a friend, family member, or attorney that you can call if you are arrested.

- ▶ If you take care of children or other people, make a plan to have them taken care of if you are detained.
- ▶ Keep important documents such as birth certificates and immigration documents in a safe place where a friend or family member can access them if necessary.
- ▶ Make sure your loved ones know how to find you if you are detained by ICE. They can use ICE's online detainee locator (<https://locator.ice.gov/odls/homePage.do>) to find an adult who is in immigration custody. Or they can call the local ICE office (<https://www.ice.gov/contact/ero>). Make sure they have your *alien registration number* written down, if you have one.
- ▶ You can call the Executive Office for Immigration Review (EOIR) hotline number at 1-800-898-7180 (toll-free) 24 hours a day, 7 days a week to get information on your case's status.

▶ **Report and document raids and arrests.**

- ▶ If it is possible and safe for you to do so, take photos and videos of the raid or arrest. Also take notes on what happened.
- ▶ Call United We Dream's hotline to report a raid: 1-844-363-1423.
- ▶ Send text messages to 877877.

### KNOW YOUR RIGHTS!

If you are stopped by immigration or the police:

- ▶ Hand this card to the officer and remain silent.
- ▶ The card explains that you are exercising your right to refuse to answer any questions until you have talked with a lawyer.

### To: Immigration or Other Officer

Right now I am choosing to exercise my legal rights.

- ▶ I will remain **silent**, and I refuse to answer your questions.
- ▶ If I am detained, I have the right to contact an attorney **immediately**.
- ▶ I refuse to sign anything without advice from an attorney.
